# CABOOLTURE SPRING SPECTACULAR QSEC SAFETY GUIDELINES

#### **QSEC IS A GLASS-FREE ZONE - THERE ARE NO EXCEPTIONS**

#### **SET UP**

- Wednesday 22<sup>nd</sup> November THERE IS ABSOLUTELY NO ADMITTANCE (apart from CKC committee and vendors) to the QSEC AREA PRIOR TO MIDDAY – this includes the carpark and all areas around the venue.
  - 1. Please wait on the QSEC oval surrounds at the end of the street in your vehicles, not in Tuckeroo Drive. (Feel free to form a queue from the front gates of the Parklands back into the oval areas as long as there is ample room for vehicles to pass into the area beside you to join the back of the queue. Common sense time here.)
  - Please adhere to this rule. QSEC have made it very clear they will not tolerate breaches to their WPHS rules and will remove exhibitors and you will not be permitted back in on Wednesday.
- AFTER MIDDAY exhibitors are allowed to:
  - 1. Come into the grounds surrounding the pavilions
  - 2. Put down their gazebo mats outside on the grass or alternatively put up a gazebo outside.
  - 3. Wait in an orderly queue until QSEC have approved our final set up to enter the pavilions to put down their mats.
- WE WILL ANNOUNCE when you can enter the pavilions. Please use some common sense and not run through the area.
- We ask for you to be mindful of others. Please put your mats right next to another mat to
  maximize exhibitors being able to share all areas. You will need to leave walkways for people and
  keep exits clear, and understand if you are set up in an area deemed unsafe by QSEC then you will
  have to move.
- No pegging down or roping off in any area.
- The Caboolture city end of Pavilion 2 (Groups 4-7) which is fenced with brown palings is available for car and gazebos, not trailers.
- Gazebo and car parking on the grassed area on the Beerburrum side of Pavilion 1 (Groups 1-3).
- Those exhibitors who have purchased a mat, we have decided to keep those in their bags at the Show Secretary's office so you can collect them and put them down as you wish. Please have your Show Manager receipt with you!

#### **PARKING AND DRIVING**

- There is parking in multiple places around the venue, please refer to the map, and check with either a CKC Member or myself if you are unsure.
- Please do not park in any area that is specifically not for parking as per the map, or common sense.
- Additional parking (LOTS of it) is available less than 100 metres away on the main ovals at QSEC at the end of Tuckeroo Drive. Just use the Drop and Go area for your dogs and gear and then park your cars there. We suggest ALL trailers should use this option.
- Please observe the speed limit of 20 kms per hour as this is a shared pedestrian, dog and vehicle
- The ring road is ONE WAY, please do not risk not following this rule.
- The Drop and Go areas on the Beerburrum Rd side and the camping area side of the Pavilions are strictly less than 5 mins.
- Cars only are to park in the front bitumen car park, no trailers or Winnebagos.

## LIQUOR LICENSING

- Pavilion 1 and its surrounds are a licensed area. This means all alcohol consumed in this area must be purchased at the bar located on the camping ground side of Pavilion 1. No alcohol purchased in this area can be taken out of the licensed zone.
- ALL other areas including Pavilion 2 and the camping grounds are not licensed. The normal no glass
  policy applies in all areas.
- QSEC will have security on hand to ensure State Government Liquor Licensing rules are adhered to.

## **CATALOGUES, QUERIES and show stuff**

- The Show Secretary's Office affectionately known as the Gamgee Room (is located in what QSEC calls the Performers' Room) which is at the Drop and Go point on the camping side of Pavilion 1.
- Exhibitors can collect their numbers and catalogues from the Gamgee Room once we announce on Thursday. They will also be able to collect an exhibitor bag. Please note that dogs co-owned etc will only get one bag, and not all bags are the same.
- All in Group and In Show winners, TAL Breeders' Team Winners and Group Place-Getters, and The Amish Challenge Winners and Finalists, Junior Handler winners and Tiny Tots competitors will need to go to the FFIRE PHOTOGRAPHY stand to have your photograph taken after the Group/competition concludes.
- BOB and Group winners will need to go to the Vendors' tents to collect their prizes.
- Tiny Tots competitors will need to put their name down at the Pet Accessories Warehouse stand (in the Vendors' Tent adjacent to the Café) on Thursday or Friday so that PAW can ensure there are enough prize packs for all children. Please do this on Thursday if you are in attendance, we don't want children to miss out.
- The Grooming Masterclass will need to speak directly to Jarrod Tyler to finalise all details.
- The Sue Huebner Seminar will be held in the Judges' Dining Room at the front left hand side of QSEC main pavilion. Please note that participants are asked to bring a pen and paper and their own drinks, a small morning tea is provided courtesy of Caboolture KC. Only those participants on the list may attend.

#### **CAMPING**

- ALL camping enquiries are to be directed to QSEC staff, not to myself or CKC committee. WE DO NOT handle camping, nor make the rules.
- Please ensure you keep your dogs on leads and remember that this is still a shared vehicle and pedestrian area.
- Should you need assistance outside of hours IAN and SANDRA LUCHTERHAND will be our camping wardens. We thank them greatly for this, and hope that you will make their weekend peaceful, not stressful.
- Please be respectful of the property at all times. Leave the camp kitchen and bathrooms clean this is your home and the home of others for the next few days.
- The wash bays may be used for washing dogs if needed.

## **GENERAL RULES**

- Respect the grounds and the property AND the QSEC staff, please follow any directions given.
- Pick up all dog droppings and hair! There are poo bags located at the writers' desks and on stands at various access points around the pavilions. DO NOT go anywhere without a poo bag with your dogs!
- Pick up all rubbish.
- Please leave the toilets clean and if there are issues with them let a QSEC staff member know immediately. There are staff members on duty all weekend to assist you.
- Smoke only in the designated smoking area please.
