COVID 19 ERA RING PROCEDURE

OUTSIDE RINGS

If you don't own it or have responsibility for it, don't touch it.

Keep at least 1.5 metres apart or maintain 2 square meters distancing.

No handshaking, hugging or kissing.

Use provided sanitiser provided at the gates when entering and exiting the grounds.

ALL RINGS

Only the Judge shall place out markers, including the stay markers. The Judge shall retrieve the markers at the conclusion of the class and place into the trial box.

There shall be only one steward in the ring. If two stewards are available, the second steward shall remain outside the ring, except for the figure 8 (4.5 metres apart), and shall be responsible for marshalling competitors and writing up the outside score board.

The competitor shall not enter the ring until called by a steward.

The Stewards Table shall be placed inside the ring.

The competitor shall bring their equipment to the ring in an open rigid box that is big enough to allow each item of equipment to be accessed without moving other items within the box.

The box shall not be brought into the ring or placed on the Stewards Table until the competitor is called into the ring.

Otherwise, only the steward and judge may place items on the Table.

When asked to remove the lead, the competitor shall remove the lead and retain on their person (preferably in a pocket). At the finish of the last individual exercise in the class, the competitor shall immediately put the dog back on lead.

At a time to be advised by the Judge, the Judge shall orally advise the Steward of each competitors scores. The steward shall write the scores on the outside scoreboard. The scoreboard will be a whiteboard on the side of the club house. Only one person at a time shall be within 1.5 metres of the scoreboard.

CCD & NOVICE RINGS

During the Stand for Exam, the Judge shall retain their Judging Chart and it shall not be taken by the steward.

For the Retrieve on the Flat exercise, the handler shall retrieve the dumbbell from their box on the Stewards Table and return it to their box when the exercise is finished (or retain it on their person). In the event of a re-throw being required, the competitor shall retrieve the dumbbell.

OPEN RING

Only the Steward shall adjust the jumps for each competitor.

During the Stand for Exam, the Judge shall retain their Judging Chart and it shall not be taken by the Steward.

For the Retrieve on the Flat exercise, the handler shall retrieve the dumbbell from their box on the Stewards Table and return it to their box when this exercise or the Retrieve over the Solid Jump exercise is finished (or retain it on their person). In the event of a re-throw being required, the competitor shall retrieve the dumbbell.

For the Directed Retrieve exercise the Judge shall place the gloves using tongs. The competitor shall retrieve the remaining glove when the exercise is finished.

UD RING

Only the Steward shall adjust the jumps for each competitor. If necessary, to reduce the Stewards workload, the Judge could adjust one (the same each time) of the jumps.

The competitor shall bring their seek back article to the starting marker and retain on their person at the finish of the exercise. Should the article not be retrieved, the competitor shall retrieve it.

The same (one) Steward shall take out (using tongs) from their container the Scent Discrimination articles to be scented and also place (by hand) the unscented articles on the ground or mat. The articles to be scented shall be placed in the mug provided. The Judge shall not take the retrieved articles from the competitor. The Steward shall take the retrieved articles from the competitor and place them into their container using the tongs used to place the scented articles.

For the Directed Retrieve exercise the Steward shall place the gloves using tongs. The competitor shall retrieve the remaining gloves when the exercise is finished.

Only the Judge shall handle the Food Refusal containers.

UDX RING

In the Seek Back with Decoy exercise, the Judge shall remove the article to be scented from its container using tongs. The Steward shall place the unscented article on the ground by hand, leaving its container on the Table. When the exercise is finished, where the scented article is retrieved the steward shall recover the article not retrieved (unscented) and return it to its container before proceeding to the next exercise. Where the unscented (incorrect) article is retrieved the competitor shall recover the article not retrieved.

In the Scent Discrimination Judges Scent exercise, the Judge shall remove from their container using tongs the cloths to be scented and the remainder shall be placed on the ground by the steward by hand.

Only the Steward will handle the container.

The competitor may use tongs to show the dog the Judge scented cloth or may wear disposable gloves (provided by the Club) during this exercise. These tongs shall be provided by the competitor who shall return them to their container or retain them on their person after use. Used gloves shall be placed by the competitor into a garbage bag provided by the Club at the finish of this exercise.

If the incorrect cloth is retrieved, the Judge shall pick up the scented cloth from among the other cloths and return it to its container.

In the Multiple Retrieve exercise, the Steward shall place the three articles using tongs. The competitor shall retrieve the remaining article when the exercise is finished and return it to its container along with the retrieved articles.

RING PACK-UP

At the conclusion of judging in each ring, any available person may assist in the ring pack-up, including rolling up the ring chain, carrying corner poles, jumps and tables to the containers.

Equipment should be left in the area between the containers.

Any person handling equipment should wash or sanitize their hands both before and after handling the equipment.
